## **Treatments**

**Radio Frequency (RF):** This is a controlled application of RF heating of deep skin with cooling of the surface skin. It is a newer technology, which heats the underlying skin collagen promoting new collagen formation. The benefits of RF are tightening of loose / sagging skin. This treatment triggers skin regeneration and new collagen is produced. This helps to further tighten skin, resulting in healthier, smoother skin and a more youthful appearance. The therna lift treatment carries with it possible health complications and consequences, which include but not be limited to reddening, swelling, bruising, pigment changes, and burn / blistering. If you bruise easily it is recommended to take Arnica to reduce bruises and the duration of appearance.

**Nano fractional Radio Frequency (RF):** The nano fractional radio frequency delivers columns of RF energy to the tissue, designed to damage the existing collagen, stimulating the body's natural healing process. Once the collagen has been damaged the body begins to repair the collagen by replacing the damaged cells with new collagen. The RF also stimulates the body to produce new fibroblasts, the "factories" that create collagen, thus increasing the amount of collagen in the tissue. This wound healing response creates a "resurfacing" or smoother appearance to the skin, plumps fine lines/wrinkles, reduces acne scars, removes pigmented lesions, and textural irregularities of the skin. The nano fractional RF treatments carry with it possible health complications and consequences, which include but are not limited to redness, swelling, blistering, bruising, skin indentations, subcutaneous fat loss, permanent scarring, changes to pigmentation, open sores, and infections.

**Ultrasonic Fat Cavitation:** This is a process that uses Ultrasonic sound waves (Ultrasound) to penetrate the epidermis into the subcutaneous fat layer. The treatment which uses 28 kHz to 40 kHz frequency assists with the breakdown of fat cells by creating micro bubbles that increase the pressure around the adipocyte and force it to implode, thus breaking down the adipocyte's cell membrane. The ultrasound cavitation Treatment carries with it possible health complications and consequences, which include but not be limited to the risk of pacemaker bruising, pacemaker failure, birth defects/miscarriage if pregnant, lactation complications, hyperglycemia, hypercholesterolemia, pancreatitis, infection, scarring, and or allergic reaction to any products used, excessive thirst, dehydration, and nausea.

**I-Lipo Light:** This treatment is an application of a 650nm – 660nm low-intensity infrared laser light, which has been shown through extensive research to cause the triglycerides within the fat cells to break down into free fatty acids (FFA) and glycerol which then are released through channels in the fat cells. The fatty acids and glycerol are then transported around the body by the lymphatic system, to tissues that will use them during metabolism to create energy. Independent clinical studies have shown i-Lipo to be, in some cases, comparable to results in liposuction. Non-invasive low-level laser therapy has been approved by the FDA. This i-lipo light treatment carries with it possible health complications and consequences, which include but not limited to slight burns/blisters, tenderness, and reddening of the target area.

**EMSculpt:** The non-invasive treatment utilizes HIFEM (High-Intensity Focused Electromagnetic) technology to induce powerful muscle contractions not achievable through voluntary contractions. When exposed to strong contractions, the muscle tissue is forced to adapt to such extreme conditions. It responds with a deep remodeling of its inner structure that results in muscle building and sculpting your body. The end results show that muscle

fibers are developed and metabolization of fat cells in the treatment area. The emsculpt treatment carries with it possible health complications and consequences, which include but are not limited to muscle ache, tenderness, and redding of target area.

**Intense Pulsed Light (IPL):** The technology uses a high-powered, hand-held, computer-controlled flashgun to deliver an intense, visible, broad-spectrum pulse of light. Various cutoff filters are used to selectively filter out shorter wavelengths, especially potentially damaging ultraviolet light. The resulting light has a spectral range that targets specific structures and chromophores ie..melanin in hair, melasma, oxyhemoglobin in blood vessels, sun damage, brown spots, discoloration, etc, that are heated to destruction and reabsorbed by the body. IPL shares some similarities with laser treatments, in that they both use light to heat and destroy their targets but unlike lasers that use a single wavelength of light which only treats one condition, IPL uses a broad spectrum that allows it to be used against several conditions. The IPL treatments carry with it possible health complications and consequences, which include but are not limited to burns-blisters, skin redness, tenderness, swelling, and bruising.

**Detox Wraps & Body Scrubs:** Detox wraps and scrubs are procedures that use various techniques and products to help remove toxins from the body, exfoliate dead skin cells, and leave the skin feeling rejuvenated. Risks include, but are not limited to, skin irritation, allergic reactions, and discomfort. In rare cases, burns or other adverse reactions may occur.

**Hyaluron Pen:** The hyaluron pen treatment is a non-invasive procedure that involves using a pen-like device to infuse hyaluronic acid into the lips or skin. The device uses air pressure to create a controlled injection of hyaluronic acid. Risks include, but are not limited to, redness, swelling, bruising, and discomfort. In rare cases, infections or allergic reactions may occur.

**Teeth Whitening:** Teeth whitening is a cosmetic procedure that uses a chemical process to remove stains and discoloration from teeth. The treatment may involve the use of bleaching agents such as hydrogen peroxide or carbamide peroxide. Risks include, but are not limited to, sensitivity, gum irritation, and discomfort. In rare cases, tooth enamel may be damaged.
